

Ordinance
on Spatial Planning in the German Exclusive Economic Zone in the Baltic Sea
(AWZ Baltic Sea-ROV)

of December 10th 2009

(unofficial translation)

Based on § 18a para. 1 of the Federal Spatial Planning Act from August 18th 1997 (BGBl. I p. 2081, 2102), which was last amended through Article 10 No. 2 of the act from December 9th 2006 (BGBl. I S. 2833), in conjunction with § 29 para. 1 Federal Spatial Planning Act from December 22nd 2008 (BGBl. I S. 2986) the Federal Ministry of Transport, Building and Urban Affairs enacts:

§ 1

Spatial planning in the German Exclusive Economic Zone in the Baltic Sea

For the German Exclusive Economic Zone in the Baltic Sea the targets and principles of spatial planning, with regard to its economic and scientific use, with regard to safety and efficiency of maritime traffic as well as for the protection of the marine environment, are being determined as a Spatial Plan, comprising text and map, in accordance to the attachment of this ordinance. 1) 2)

§ 2

Coming into Effect

This ordinance will come into effect the day after its promulgation.

Article 9 para. 4b of SEA-Directive) and the description of the monitoring measures (cf. Article 9 para. 1c of SEA-Directive) will be open to public inspection from the moment of promulgation of this ordinance at Bundesamt für Seeschifffahrt und Hydrographie (BSH, Federal Maritime and Hydrographic Agency), Bernhard-Nocht-Straße 78, 20359 Hamburg and Neptunallee 5, 18057 Rostock (cf. § 19 para. 2 in conjunction with § 11 para. 2 of the Federal Spatial Planning Act from 22.12.2008 (BGBl. I S. 2986)). The summary environmental statement and the description of the monitoring measures are at the same time included as chapter 5 in the text of the Spatial Plan.
